California attorney & CDLA member **David Salvin** will address some new laws specific to DUI defense and also include other aspects of firearms law for general criminal defense attorneys.

PRESENTER: DAVID J. SALVIN

California attorney David J. Salvin has been practicing in the fields of criminal defense and estate planning for almost 30 years.

His practice in firearms law involves not only the defense of those accused in firearms related crimes, but also the representation of State and Federally licensed firearms dealers, in dealing with the California Department of Justice and the Federal ATF. David also consults with firearms collectors and everyday shooters to legally configure their firearms for importation, acquisition, and continued possession in the ever-changing legal landscape here in California.

His practice in estate planning includes general estate planning (wills and trust creation and administration) as well as probate administration and litigation. As a firearms law attorney, his experience with and connection to the firearms industry is invaluable in assisting clients in evaluating firearms collections for legality, modifying those weapons no longer legal in California, and assisting the estate representative to evaluate, value, distribute, and/or sell firearms collections.

David works with clients all over California to regain their firearms rights following 5150 holds or restraining orders and to recover firearms from police custody however they were seized.



5.) MEMBER SPOTLIGHT: JOSHUA PRICE



Based in San Diego, California, Attorney **Joshua Price** has been practicing DUI Defense exclusively since 2009 throughout Southern California. Although the last few years he primarily practices in San Diego County. He will travel for anyone willing to fight their case!

Attorney Joshua Price is the founder and owner of Defending Rights Law Center, Inc. which is a full-service DUI Law Firm. He and his team handle everything from pre-trial hearings, motions, trials, DMV hearings, writs and appeals.

Price says, "Our firm's typical client is someone similar to people I know and can connect with on some level - usually a good person who is hard working and often times has a family. That is what makes most DUI cases easy to get behind as it is not illegal per se to drink and drive, or smoke marijuana and drive, or taking prescription medication and then drive a vehicle.

It is only unlawful if you are under the influence of alcohol and/or drugs or at or above a .08 percent blood or breath alcohol level. The key to success is to not take anything for granted and put the same concentrated effort into every client's case."

Attorney Joshua Price says that continuing education and training is key to keeping up with changes and trends in the law and the legal community. He backs his beliefs with action.

He has gone through the same training as law enforcement officers when it comes to Standardized Field Sobriety Testing. He attended a three-day, 24-hour training and testing to become qualified in administration of these tests pursuant to the National Highway Traffic Safety Administration (NHTSA).

He attended a two-day, 16-hour, Advanced Roadside Impaired Driving Enforcement (ARIDE) training where he learned more advanced techniques and testing that law enforcement use to try to detect drugs other than alcohol in DUI investigations.

He attended a five- day, (more than 40 hours of training) at Shimadzu Laboratory at University of Texas, Arlington. The Serious Science Blood Drug Analysis course combined hard science and trial advocacy. He learned the basics of metrology, blood alcohol and the more complex blood drug analyses, and got hands-on experience preparing and analyzing samples of blood for detection of various drugs.

Typically, he attends 20-30 hours of CLE's a year related to DUI training.

He is a specialist member of California DUI Lawyers Association (CDLA). He was voted to the Board of Directors for the Association in 2017. He is the immediate Past President of CDLA.

6.) QUESTION OF THE MONTH: WHEN WAS CDLA FOUNDED?

In **1989** *Edward Kuwatch* created an organization called the "California Deuce Defenders" (CDDD), after the most common term for a DUI, a "deuce". (Deuce refers to the two charges - California Vehicle Code section 23152(a) and 23152(b) - that are usually filed and alleged in a DUI case). The name was later changed to the California DUI Lawyers Association. To honor its founder, both CDLA's annual conference and its most prestigious lifetime achievement award are named after "Fast Eddy."

CDLA will be celebrating its 35th anniversary in 2024!
