## WEBINAR DESCRIPTION

This webinar will focus on Disconnect Defense-Focus on GERD/LPR and general discussion of other disconnect defenses. Breath alcohol testing is subject to many potential flaws. One of the best possible defenses is when you have a client who has a high breath alcohol level and who swears that the amount of alcohol consumed could not have amounted to anywhere close to a .08%. He/she looks sober and has Gastro Esophageal Reflux Disease (GERD) or Laryngopharyngeal Reflux (LPR). In this presentation, CDLA Immediate Past President Joshua Price will walk through how to successfully present this defense at trial.

## PRESENTER: JOSHUA PRICE



Based in San Diego, California, Attorney Joshua Price has been practicing DUI Defense exclusively since 2009 throughout Southern California. Although the last few years he primarily practices in San Diego County.

He will travel for anyone willing to fight their case! Attorney Joshua Price is the founder and owner of Defending Rights Law Center, Inc. which is a full-service DUI Law Firm. He and his team handle everything from pre-trial hearings, motions, trials, DMV hearings, writs and appeals.

Attorney Joshua Price says that continuing education and training is key to keeping up with changes and trends in the law and the legal community. He backs his beliefs with action. He has gone through the same training as law enforcement officers when it comes to Standardized Field Sobriety Testing. He attended a three-day, 24-hour training and testing to become qualified in administration of these tests pursuant to the National Highway Traffic Safety Administration (NHTSA).

He attended a two-day, 16-hour, Advanced Roadside Impaired Driving Enforcement (ARIDE) training where he learned more advanced techniques and testing that law enforcement use to try to detect drugs other than alcohol in DUI investigations. Josh also attended a five- day, (more than 40 hours of training) at Shimadzu Laboratory at University of Texas, Arlington. The Serious Science Blood Drug Analysis course combined hard science and trial advocacy. He learned the basics of metrology, blood alcohol and the more complex blood drug analyses, and got hands-on experience preparing and analyzing samples of blood for detection of various drugs. Typically, he attends 20-30 hours of CLE's a year related to DUI training.

He is a specialist member of California DUI Lawyers Association (CDLA). He was voted to the Board of Directors for the Association in 2017. He is the immediate Past President of CDLA. His last 3 GERD DUI Jury Trials: 1. Not Guilty on a .14/.13 Breath alcohol test case; 2. Not Guilty on a .11/.11 Breath alcohol test case; 3. Hung Jury on .17/.16% breath alcohol test case.

Attorney Joshua Price has been awarded the AV Preeminent rating from Martindale-Hubbell since 2021-present. He has 3 children: Braylon (5), Kaeden (3), and Zaraiya (12 months old) and just celebrated his 7<sup>th</sup> wedding anniversary with his wife, Alicia. When he is not practicing DUI Defense or chasing kids around, he is an active Mountain Biker, soccer player and snowboarder. #### 3.) TWO REQUESTS FROM CDLA PRESIDENT MANNY DASKAL

#### **LEGISLATIVE CONNECTIONS**

In line with our recent victory in *CDLA v. DMV*, our Association needs to become more active in interacting with our State legislature in promoting DUI-related legislation.

We have seen the DMV try to circumvent the implementation of this lawsuit and the need to seek assistance in compliance with the conditions of CDLA v DMV.

We are confronted daily with the DMV/AG maneuvering to resist compliance. In addition, we need to confront the loss of in-person hearings and hearings being conducted from foreign offices throughout the State. Those offices are unfamiliar with our local topography and cultures. The vicinage requirement has completely disappeared. In addition, the DMV "office staff" has implemented issuing SDTs in multiples cases on behalf of the DMV Hearing Officer. This practice allegedly allows the "separation of powers" demanded from the holding in CDLA v DMV.

Our organization has recently formed a Legislative Committee to work with and advocate before the Legislature. (Our lawsuit took a number of years and many thousands of dollars to pursue.)

## 4.) CHRIS MARKELZ GETS DMV STATUTES HELD UNCONSTITUTIONAL!

NOTE: This information was provided by *Richard Middlebrook* via the CDLA listserv.

"In a huge win, CHRIS MARKELZ slayed the dragon and got multiple DMV related statutes held unconstitutional. So when your client gets kicked out of their DUI classes and you now get a right to a hearing (eventually) you have Chris' brilliance to thank. This kind of decision is nearly impossible but is indicative of the fight we need to be putting up daily. It came down today and he got the injunction!

The case is Randolph v. DMV out Los Angeles Superior where Judge Chalfant held and ordered, "Sections 13352(e)(2), 13352.4(1), 13353.75(a)(1)(C), and 13353.6(a)(1)(C) are facially

unconstitutional as a matter of due process because they do not provide the driver an opportunity for an administrative hearing to determine whether his or her driver's license should be suspended or revoked after the DMV receives notification from a DUI program that the driver has been dismissed from the program. The DMV is required to provide at least a paper hearing in which the driver can contest his or her dismissal from the program. These statutes may not be enforced against a driver without the opportunity for such a hearing and an injunction will issue to that effect.

Chris and his team are absolute warriors. We are lucky to count him among our members!"
