3.) **LEGISLATIVE UPDATE: AB366**

AB366 seeks to make permanent and expand ignition interlock device (IID) requirements across all DUI offenders in California. Key elements include requiring IID installation for all first-time and repeat DUI offenders and extending current provisions indefinitely (they currently expire January 1, 2026).

On August 18, 2025, this bill was placed on the Suspense File in the Senate Appropriations Committee (7 Yes, 0 No)—a typical step for bills with fiscal implications, pending final decisions.

The Suspense File is where bills with potential budget impact are held temporarily in the Senate Appropriations Committee. The bill must clear this hurdle by being taken off the Suspense File—with either a recommendation to advance or to hold—before moving toward a full Senate floor vote.

Its fate now rests with the Senate Appropriations Committee, who must decide whether to move it forward for a full Senate vote.

7.) THE LAST WORD: AI-GENERATED ATTORNEYS?!

FROM CHATGPT:

In late March 2025, a man named Jerome Dewald appeared pro se (representing himself) before the New York State Supreme Court Appellate Division's First Judicial Department in an employment dispute.

- Dewald submitted a pre-recorded video for his oral argument. Instead of appearing himself, the video showed an AI-generated avatar—a digitally created well-dressed young man—speaking to the judges.
- Nobody in the courtroom had been informed that the "lawyer" in the video was not a real person. As soon as the avatar began speaking, Justice Sallie Manzanet-Daniels paused and asked: "Is that counsel for the case?"
- Dewald replied, "I generated that. That's not a real person." The judge was clearly displeased, stating, "It would have been nice to know that when you made your application. You did not tell me that, sir. I don't appreciate being misled." The court promptly terminated the video.
- Dewald later issued an apology, explaining that his intention was to use the AI avatar because he struggles with public speaking, not to deceive the court. As of the latest reports, his appeal remains pending.

Broader Implications

This incident marks a significant milestone in the clash between emerging AI tools and traditional court protocols. While AI-generated avatars might offer assistance, especially for those with disabilities or public-speaking challenges, courts are unlikely to accept them without clear disclosure and guidelines.

Legal experts warn that as such technology becomes more accessible, self-represented litigants might increasingly experiment with it—raising critical concerns around transparency, authenticity, and ethical use in judicial settings.
